**2. CONTEST BASIC CONDITIONS**

**2.1 Purpose**

The purpose of this contest is the creation of Christmas Cards related, directly or indirectly, to Formula One and, in particular, Christmas Cards showing any connection with the Formula One Driver, Fernando Alonso Díaz.

Among all the drawings or Christmas received, Fernando Alonso himself will pick out the winner one.

**2.2 Enabled participants**

The contest is directed to youngsters up to fourteen years old.

### **2.3 Drawings and submission**

Creations can be made in color or black-and-white format and must be presented at DIN-A4 size.

Drawings shall be sent with the participant personal details enclosed to the following address:

Closing date will be on November 23rd, 2007 by 24 hours.

In addition, on the other side of the draw, the participant shall answer to the following question:

*In what way you would like to be like Fernando Alonso?*

### **2.4 Decision**

The winner election will be carried out by Fernando Alonso himself, and the name of the winner will be announced at this website on December 3<sup>th</sup>, 2007.

### **2.5 Award**

Contest winner will receive A PAIR OF GLOVES SIGNED BY FERNANDO ALONSO

### **2.6 Non- admission**

The organizer will be fully free to reject Cards showing any racist or sexist contents or drawings committing any kind of outrage against Fernando Alonso image, according with the present contest details.

They can also be rejected if they do not satisfy heading 3.1 of the following basis.

### **3. LEGAL INFORMATION**

#### **3.1 Data Protection**

According to Personal Data Protection Act (15/1999, December 13<sup>th</sup>), and in order to comply its regulations, personal data provided within the drawings and mailing submitted under this contest, will be disposed into files, not only computerized but also standard ones, and which purpose shall only be the proper contest administration.

GESPUAM S.L. Internal Organization Department will be the recipient.

In compliance with the present conditions, participants will have to be under the age of fifteen; drawings shall be submitted to GESPUAM S.L., (as the file responsible), to the address pointed out under heading 2.3 with their personal data details, enclosed with their father's, mother's or tutor's signature or any representative entitled to act on their behalf, and agreeing with the data processing.

GESPUAM S.L., guarantees the possibility of accessing to personal data, as well as to rectification, cancellation, and opposition to the data handed out. Likewise, GESPUAM S.L. ensures data confidentiality to be respected and compromises to give a proper use under the purposes described in these conditions.

#### **3.2 Conditions acceptance and refusal to any action against the organizer or the Driver, Fernando Alonso.**

The only fact of sending any drawing in order to participate in this contest implies the acceptance of the current conditions, and also the renounce to any legal or extra-legal action against the organizer or the Driver as a result of the current competition.

#### **3.3 Renounce to drawings rights.**

Taking part into the contest involves the automatic authorization by the participant and his renounce to the drawings rights on behalf the organizer, in order to be enabled to use them without any gainful or lucrative purposes.
